### Webinar: diversity management in local areas.

## Description

The webinar will provide an introduction to the topics of Diversity, Equity, and Inclusion (DEI). We will begin with a reflection on personal identity through the lens of the **Wheel of Power**. The discussion will encompass the intersectionality of identities and will explore the benefits of diversity. Additionally, we will examine the needs associated with inclusion and the distinction between equality and equity in the context of building social justice. The objective of this workshop is to enhance understanding of Diversity, Equity, and Inclusion (DEI), particularly at the level of local policies. The presenter will introduce the key elements of the human rights framework, in accordance with the recommendations of the European Union Agency for Fundamental Rights.

We will focus on Foundations, Structures, and Tools to systematically trace the process of implementing the Human Rights Framework. We will also consider what qualifies a city to be designated as [a City of Human Rights](#). The concluding discussion will focus on addressing the challenges faced by webinar participants, as well as exchanging best practices in the area of social inclusion. We will also discuss participatory processes aimed at engaging local communities in the design of public spaces and explore networking opportunities to enhance inclusion efforts.

## Presenter

Eliza Gaust - Graduate in Cultural Studies, Trainer in the area of DEI [Diversity, Equity & Inclusion] and anti-discrimination initiatives. She has been active for many years in the field of equal treatment and human rights. She gained experience in public institutions, non-governmental organizations, local government, and by collaborating with the business sector. For many years, she worked at the Marek Edelman Dialogue Center and later served as the Plenipotentiary of Equality Policy under the Mayor of Łódź. Since 2013, she has been coordinating the Living Library in Łódź. She co-founded the Łódź of Diversity Coalition, bringing together individuals from minority groups and those with migration experiences living in Łódź. Graduate of

the Flying University of Human Rights and the Ashoka course & DEI Learning Journey.”

Originator and leader of the "Szkoła klasa" program. She develops educational programs, textbooks for students, lesson plans and guides for teachers, programs and training materials. She edits publications issued by the Center. She conducts training for teachers and trainers. In 2011, she was awarded the Officer's Cross of the Order of Polonia Restituta for her outstanding contribution to building a civil society in Poland after 1989. She believes in citizens' democracy, wise education and the power of common sense.

**Monika Slaninová** is a project coordinator and manager of Europe Direct Banskobystrica Region with extensive experience in the field of rural development, civic engagement, and youth work. She coordinated several international projects through the Erasmus+ program and other initiatives aimed at sustainable development. She worked on the Horizon 2020 PoliRural project.



where she contributed to the creation of the document "Vision for More Attractive Rural / which should become a binding document for the Slovak government in the future. He actively participates in the promotion of the Rural Pact in Slovakia. She is a member of several NGOs, an ambassador of the European Citizens initiative, and is currently working/learning the Democracy Reloading, Europe Goes Local, and European Youth Village programs.

**Tony Venables** is the Founder of ECIT – a foundation working on European Citizens started his career as a European civil servant, before heading up the consumer group (European Bureau of Consumer Unions) and setting up ECAS (European Citizen Action Service) is the author of the book Piecing Together Europe's Citizenship.

**Joanna Kopacka** is a Program Coordinator in the Engaging Central Europe (ECE) initiative German Marshall Fund, which combines civil society support with analytical and research work on political developments in Central and Eastern Europe. Her work focuses on democratic backsliding and innovative approaches to mobilization and civic responses to populism across the region. Before joining GMF, Joanna worked at the intersection of civic engagement, human rights, and democratic accountability with several nonprofit organizations. Most recently, at Invest in Europe, an international cooperative of investigative journalists, and WeMove Europe, an organization fostering citizen-driven politics and community organizing across the continent, including through the European Citizens' Initiative (ECI).

## 17 January 2024

Internal meeting of the international partners of the GroundUp project, accompanied by close stakeholders and youth. Active participation is required throughout the day. This debate will encourage participants to think critically about both the advantages and limitations of digital citizenship rights and how they impact real lives, and solidify their understanding of digital policies, and participation mechanisms, while also thinking about how these can be applied and further explored individually.

- Main takeaways/ findings from the event with the focus on:

1. The event focused on deepening knowledge about EU citizens' rights to free movement, work, study, and residence across borders. Discussions highlighted the challenges and opportunities of these rights in different EU Member States. Special attention was given to the European Citizens' Initiative (ECI) as a tool for citizen engagement and policy change.
2. Diversity, Equity, and Inclusion (DEI) in Local Communities. The webinar on Diversity Management in Local Areas explored how municipalities and Local Action Groups can implement DEI policies. A key insight was the difference between equality and equity in the context of social justice and inclusion. The role of human rights-based approaches (HRBA) in local governance was emphasized, with practical tools provided for policy implementation.
3. Education as a driver of EU citizenship awareness. The panel discussion on European Citizenship and Education stressed the importance of integrating EU-related topics into school curricula and youth programs. The "Teach Me Europe" initiative was introduced, advocating for EU-wide citizenship education. Experts emphasized critical thinking, civic engagement, and motivation as essential skills for active European citizenship.
4. Exchange of best practices across Europe. Case studies from municipalities such as Irschen (Austria) and LAG Prealpi e Dolomiti (Italy) showcased successful inclusion initiatives.
5. Critical Reflection on the status and future of EU Citizenship. The Oxford Debate (in January 2025) encouraged participants to critically analyze whether the Maastricht Treaty's provisions on EU citizenship are sufficient for full inclusion and protection across the EU. The debate aimed to develop a more nuanced understanding of EU policies, participation mechanisms, and areas for future improvement.

**Main take-aways according to the participants:**

The discussion on the difference between equity and equality, along with the entire presentation on DEI (Diversity, Equity, and Inclusion) in local government, was highly insightful. The LAG Prealpi project was particularly inspiring and impactful.

Sharing good practices and learning about these issues is always a great way to expand our curiosity and knowledge on how to implement human rights in our communities and institutions. Activities like these encourage reflection on our work and our role in society.

I gained valuable knowledge about European policies and current discussions at the EU level. The event highlighted key competencies we all need to develop, particularly critical thinking and motivation.

The session on HRBA (Human Rights-Based Approach) in practice was thought-provoking, especially regarding how to take it to the next level.

I feel even more connected to the European dimension, having learned about the European Citizens' Initiative (ECI), Slovak projects, and the Polish experience in Central Europe.

I also learned about tools used to track the implementation of policies. One key takeaway was a golden quote: "The level of inclusivity in a community is a direct measure of the implementation of human rights."

The discussions provided valuable insights on preventing discrimination caused by a lack of inclusion, methods to work with marginalized groups, and ways to optimize daily behaviors to be more inclusive.

I now have a clearer understanding of the topic, its significance, and the potential goals and opportunities ahead. While challenges exist—often similar across different contexts—it is always worth starting and making an effort to build something. I realized that even small steps matter, and taking them gradually is far better than not trying at all. Good education and the dissemination of accurate information can lead to meaningful positive change.



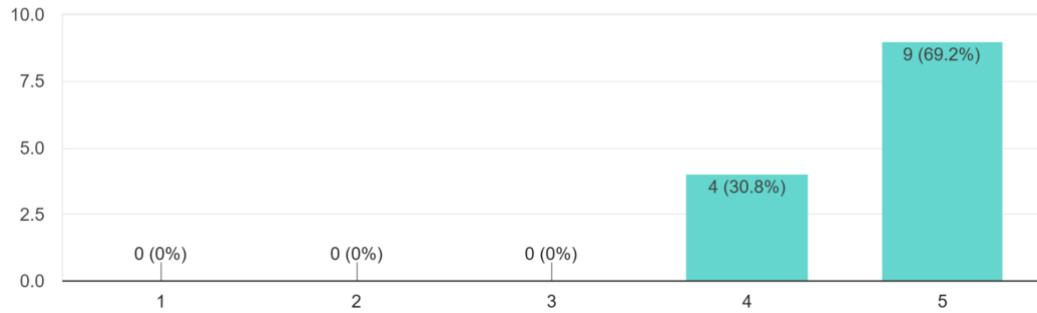


Response	Count	Percentage

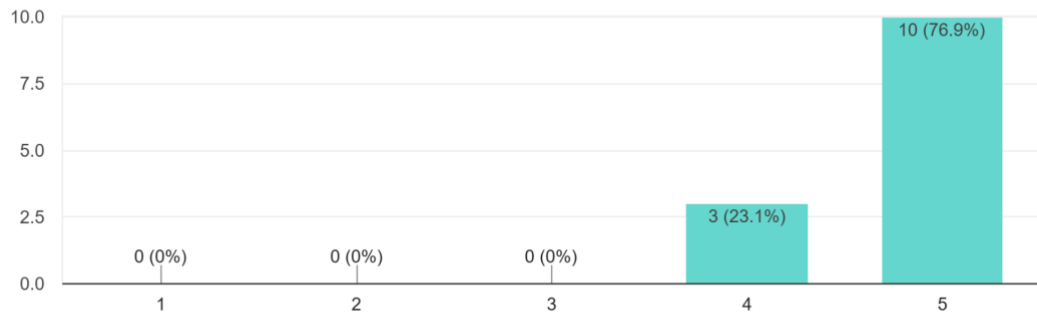
2. How satisfied are you with the event:
